Dear Colleague,

I wish to draw your attention to the observations of the Hon'ble Public Accounts Committee of Lok Sabha that systemic changes should be brought about in the Department in respect of revenue collection by implementing the observations of C & AG at national level.

2. In order to enhance our revenue safeguarding and collection mechanisms, it has been decided to disseminate the Audit Reports of C & AG on the AN TARANG. AN TARANG, as you are aware is the INTRANET platform and Knowledge Management portal for CBEC and its officers. AN TARANG allows them to collaborate securely using their ICEGATE email ids.

3. The PAC section of the Board has commenced uploading of Audit Reports/Audit Paras of C & AG and the Ministry's replies, on AN TARANG (A screenshot of AN TARANG is enclosed for your ready reference). I would urge you to give wide publicity to this facility so that your officers can update themselves about the Audit Reports/Audit Paras raised by C & AG throughout the Country. Such a national perspective would enable your officers to quickly detect and safeguard potential revenue leakage in their own jurisdictions.

I hope that this effort of knowledge management and dissemination of Audit Reports of C & AG on AN TARANG would be a powerful tool in protecting and augmenting revenue.
