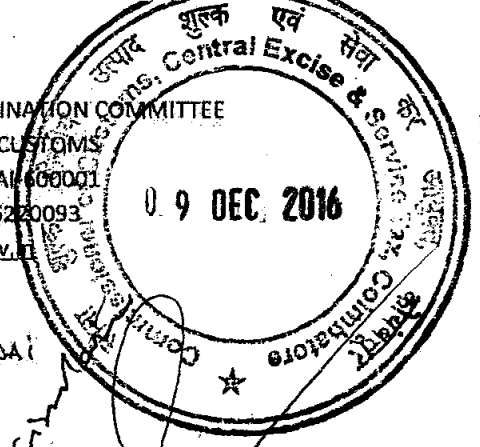

Kindly refer to the letter cited above.

It is informed that the Government of Tamilnadu has declared 13.12.2016 (Tuesday) as a public Holiday for Milad-un-Nabi instead of 12.12.2016 (Monday) vide G.O. Ms. No 931 dated: 08.12.2016.

In terms of Para 5.2 of DOPT Office Memorandum F.No. 12/8/2016/JCA-2 dated 24.06.2016 read with G.O.Ms.No.931 dated 08.12.2016 issued by the Government of Tamilnadu, the Central Government Employees Welfare Coordination Committee vide Circular No. CGEWCC/2015 dated 08.12.2016 has declared 12.12.2016 (Monday) as Closed Holiday for Milad-un-Nabi or Id-e-milad and now decided to change the holiday for Milad-un-Nabi from 12.12.2016 (Monday) to 13.12.2016 (Tuesday).

In view of above, the Closed Holiday for Central Government Employees is changed from 12.12.2016 to 13.12.2016.
