**TRADE NOTICE NO. 06/2013**

**Sub: Service Tax –Voluntary Compliance Encouragement Scheme (VCES)  
2013 – Nomination of Designated Authority under Service tax-Reg.**

The Voluntary compliance encouragement scheme (VCES) is operational with effect from May 10, 2013. The VCES is a new amnesty scheme introduced in the Finance Act'2013 to encourage voluntary compliance and to motivate defaulters to pay Service tax not paid in the past. VCES grants immunity from interest, penalty and other proceedings under the Finance Act, 1994 provided a truthful declaration of the service tax dues are made and tax paid in installments subject to the conditions and limitations specified in the scheme.

The scheme aims to provide one-time amnesty to Tax payers/ assesseees who make a declaration of his tax dues to the designated authority on or before the 31st day of December, 2013 in the form prescribed, in respect of whom no notice or an order of determination has been issued or made before the 1st day of March, 2013. The assessee shall, on or before the 31st day of December, 2013, pay not less than fifty per cent, of the tax dues so declared and submit proof of such payment to the designated authority and the tax dues or part thereof remaining to be paid after the payment made shall be paid by the party on or before the 30th day of June, 2014.

The benefits under the scheme are available to a:

- Person to whom no notice or order of determination of tax dues has been raised or issued before March 1, 2013,
- Person who has not disclosed his true service tax liability,
- person against whom, no inquiry or investigation in respect of a service tax not levied or not paid or short-levied or short-paid or no audit has been initiated, and such inquiry, investigation or audit is not pending as on March 1, 2013.

Forms and manner of declaration, acknowledgement of such declaration along with issuing acknowledgement of discharge of tax dues have been prescribed in the notification no.10/2013 ST dated 13.5.13.
